TAE Notification RE: Court Orders Regarding Sale in Error Interest Fund

On February 02nd 2022 and September 22nd 2022 the Circuit Court of Cook County entered orders that authorize the Cook County Treasurer to pay all interest and costs on sales in error on a pro rata basis from those accounts where the principal refund of the tax sale purchase was taken, effective at such times as the sale in error interest fund reaches zero balance and is depleted but no later than June 15, 2023.
